Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

The total number of fixed safety cameras you have in your police force area.

Answer

A total of 4 fixed safety cameras.

Request 2

The number of operational fixed safety speed cameras you have in your police force area at the current moment.

Answer

There are a total of 3 operational fixed safety speed cameras.

Request 3

The total number of mobile safety cameras you have in your police force area.

Answer

A total of 12 mobile safety cameras.

Request 4

The number of operational mobile safety cameras you have in your police force area at the current moment.

Answer

A total of 5 operational mobile safety cameras.

Request 5

The number of average speed safety cameras you have in your police force area and the number

and length of roads they cover.

Answer

A total of 4 average speed safety cameras and the locations of these cameras are detailed in the link provided below:

Request 6

The number of operational average speed cameras you have in your police force area.

Request 7

Do mobile safety camera vans in your police force area also detect and record in-vehicle offences such as using a hand-held mobile phone or not wearing a seatbelt? If so, how many mobile phone and how many seatbelt offences have been detected by mobile safety cameras in the last 5 years? Please show results for each year individually?

Request 8

If so, how many mobile phone and how many seatbelt offences have been detected by mobile safety cameras in the last 5 years? Please show results for each year individually.

Answers

PSNI can confirm that mobile safety camera vans cannot detect and record in-vehicle offences.

If it is not possible to provide the information requested due to the information exceeding the cost of compliance limits identified in Section 12, please provide advice and assistance, under the Section 16 obligations of the Act, as to how I can refine my request.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. If, following an Internal Review carried out by an independent decision maker, you remain dissatisfied with the handling of your request, you may make a complaint to the Information Commissioner's Office, under Section 50 of the Freedom of Information Act, and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
