

# FREEDOM OF INFORMATION REQUEST

**Keyword:** Organisational Information/Governance

**Subject:** Retention of Investigation Material

### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold some information to which your request relates and this is being provided to you. We further consider the information you seek in request number 1 is exempt by virtue of section 21 of FOIA and have detailed our rationale as to why this exemption applies. We have also provided you with links to guidance issued by the Information Commissioner's Office which we have followed in responding to your request.

## Request 1

Is there a designated length of time for which the Police Service Northern Ireland and laboratories you instruct, both internal and external, retain physical material gathered during police investigations in respect of convicted crimes?

(The phrase "physical material" above refers to all objects and items which are exhibited as part of both the "used material" at trial AND the "unused material", not subsequently used at trial.)

#### **Answer**

Section 17(1) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the information is exempt) to provide you the applicant with a notice which:

- (a) states that fact,
- (b) specifies the exemption in question and
- (c) states (if not otherwise apparent) why the exemption applies.

The exemption/s, as well as the factors the Department considered when deciding where the public interest lies, are listed below:

# Request 2

If there is a divergence of policy according to crime type, please provide clarification.

## **Answer**

There is no divergence in policy in regards to crime type, however, there is much more likelihood Officers will request detention of this property with potentially much more, future legal requirements. For example, inquests, complaints, public enquiries and civil cases.

If, following an Internal Review carried out by an independent decision maker, you remain dissatisfied with the handling of your request, you may make a complaint to the Information Commissioner's Office, under Section 50 of the Freedom of Information Act, and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act.
