Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates and the decision has been taken to disclose the following.

Request

The number of people a) arrested b) charged by officers of your force under the Vagrancy Act 1824 the Vagrancy Act 1824 (as amended by the Summary Jurisdiction and Criminal Justice Act (Northern Ireland) 1935) and Vagrancy Act 1947 in each calendar month of 2018, 2019 and 2020.

Answer

Please see the tables below detailing the number of persons arrested and charged for Vagrancy Act offences.

The following notes are applicable to the data provided

1 The data has been extracted where a person has been arrested and processed in police custody for an offence under Vagrancy Act 1824 & Vagrancy Act 1847.

Information presented is count of individuals arrested/charged each month

Person may have been arrested more than once in a month

Unique number of individuals arrested 126.

Information extracted from custody data extracts from the NICHE recording database where person arrested for an offence under the Vagrancy Act 1824 or 1847. The request has asked for persons arrested/charged per month, therefore if person arrested more than once in any one month count in the table will be 1. Figures may differ from previous requests where the information requested was for the number of arrests in a time period e.g. if arrested twice in a month then the count will be 2.

You

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
