Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

## Request

On the back of the arson attack on the Belfast Multi-Cultural Association building on Donegall Pass, I was hoping to find out some statistics about similar arson attacks on houses/cars/other property of foreign nationals in the area over the last five years.

## Answer

Table below provides Arson offences against foreign nationals in Belfast - Central ward, 2016 - 2021

The information is based on two data sets: firstly, all recorded Arson offences where the victim was not a UK or Ireland national and; secondly all recorded Arson offences where there was a racist or faith/religion motivation. Both data sets cover offences recorded in the 'Belfast - Central' ward, for the period February 2016 - January 2021.

- Where an offence has occurred in both data sets, it has only been counted once.
- Of the 11 offences identified, 4 of them had a hate motivation.
- Arson offences include 'Arson endangering life' and 'Arson not endangering life'.
