Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

For the calendar years 2018, 2019 and 2020 and the period 1st January 2021 to 28th January 2021, please could you provide the following information: The number of people aged under 18 who were arrested for firearm offences.

Answer

A total of eleven people aged under 18 were arrested and processed through police custody between 1st January 2018 and 28th January 2021.

Request 2

For each arrested person listed in your answer to question 1, could you tell me:

- Their age
- Their sex/gender
- The offence they were arrested for
- Whether the arrested person was charged

Answer

- Age 5 were aged 16, 6 were aged 17

If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
