Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

#### **Request 1**

I would like to receive information regarding the number of children under the age of 18 who have been convicted of one or more crime in Northern Ireland from 2015-2020.

### **Request 2**

If possible, I would ask that this information is broken down into ages i.e., the number of children aged 12, aged 15, etc to correlate with each year from 2015-2020.

### Request 3

Enquiries made in relation to the cost per year of keeping a young offender in custody, failed to locate any records or documents held by PSNI relevant to your request based on the information you have provided. This is post-conviction and therefore, not a matter for policing. Accordingly, I have determined that the Police Service of Northern Ireland does not hold the information to which you seek access.

### **Request 4**

I would like to receive information regarding the number of crimes committed by under children under 10 years old in Northern Ireland from 2015-2020.

### **Request 5**

If possible, I would also like to know which crimes were most commonly committed by under 10s in this time period.

#### Answer

In response to Request 4 & 5, please see the table below detailing recorded crimes1 that have since been assigned an outcome of Prosecution prevented - suspect under age.

Please note: Provided are the figures for recorded crimes based on the outcome code for <u>'Prosecution prevented – named suspect identified but is below the age of criminal</u> <u>responsibility'</u> which indicates the person involved in the offence was under ten years at the time of offence.

# However, it should be noted that if an alternative outcome code is applied to the crime, records involving a person under ten will not be identified within this search.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
