For context, please note the PSNI Legacy Investigation Branch (LIB) was established in January 2015 following the cessation of the Historical Enquiries Team (HET) in December 2014. The LIB's remit is to review those cases between 01 January 1969 and 01 March 2004 that were not concluded by the HET, as well as to conduct investigations into cases which present evidential opportunities.

LIB cases are managed and progressed according to a Case Sequencing Model (CSM), and prioritised based on various factors governing the sequencing of over 1,100 fatal incidents and involving the deaths of over 1,400 people. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
