# Request 1

To detail the number of reported dog thefts across Northern Ireland, broken down over the last three years by PSNI District.

### Answer

PSNI has a total of 11 Policing Districts, the details of the areas that they refer to can be found on the table below.

The table is based on all burglary, robbery and theft offences where property classified as 'stolen' was described as 'dog', broken down by police district, for the years 2018 - 2020.

Please Note: This information is based on data extracted from a live system and may be subject to change. It is dependent on the information having been input into the system in such a way as to identify those records that are relevant.

### Request 2

To detail the number of reported <u>attempted</u> dog thefts across Northern Ireland, broken down over the last three years by PSNI District.

#### **Answer**

There were no identified offences of attempted burglary, robbery or theft where property described as 'dog' was associated with the offence during this period.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
