Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

I am writing to you under the Freedom of Information Act 2000 to request the following information regarding the Vagrancy Act 1824 (or its equivalent(s) in Northern Ireland), from 2017-2019

Request 1

Please provide the number of arrests made by your police force under section three of the Vagrancy Act 1824 in the financial years ranging from 2017-18, to 2018-2019.

I am not seeking information on the prostitution and indecency clauses of Section 3; accordingly, the police force should use the following Section 3 offences if possible:

- Wandering abroad to beg or gather alms
- Placing self in public place to beg
- Procuring child to beg
- · Person other than prostitute being idle and disorderly
- Causing child to beg
- Collecting alms or endeavouring to procure charitable contribution by false pretence
- Wandering abroad and exposing wound or deformity to obtain alms
- Persistently beg
- Sleeping out

Clarification sought

The Vagrancy Act 1824 does not apply in Northern Ireland. The PSNI record owner has advised they may be able to search for the following offences;

CAUSING CHILD TO BEG, Section 24(1) of the Children and Young Persons Act (Northern Ireland) 1968

CAUSING YOUNG PERSON TO BEG, no legislation details available

PROCURING CHILD TO BEG, no legislation details available

PROCURING YOUNG PERSON TO BEG, no legislation details available

BEGGING, Section 3 of the Vagrancy (Ireland) Act 1847

UNLAWFUL CHARITABLE COLLECTION, Section 4 of the Vagrancy Act 1824 as amended by the Summary Jurisdiction and Criminal Justice Act (Northern Ireland) 1935

Yes, please proceed with those listed offences.

Answer

For the financial year 2017/18 there a total of 37 arrests and 2018/19 a total 60 arrests.

Please note this refers to a total of 76 persons. Please note an individual may have been arrested on more than one occasion.

A total of 18 individuals were listed as having No fixed Abode. ('NFA).

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
