Please can you provide the following information for your custody healthcare contract: The name of the current incumbent service provider?

## **Answer**

There is no single provider. PSNI engages Forensic Medical Officers on individual contract.

The vehicle/portal that you will use to procure this opportunity in the future (e.g. Bluelight)?

## **Answer**

Currently the Police Service of Northern Ireland is working with Health & Social Care in transforming the delivery of custody healthcare. Development of the model for this future service to be delivered by a Health & Social Care Trust is in the final stages.

The contract start and end date of the initial term for this contract?

#### Answer

The initial term for this contract date starts from 1<sup>st</sup> April 2019 and ends on 30<sup>th</sup> September 2020.

## **Answer**

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
