## Clarification from requester

Thanks for your request to clarify. I'm asking for the number of officials from the police force who have attendance at/work with schools as part of their regular duties, in the sense referred to in this article which speaks about the Safer Schools Initiative: <u>https://schoolsweek.co.uk/are-police-officers-in-schools-a-force-for-good/</u>.

#### Answer

Searches were conducted however these searches failed to locate any records or documents relevant to your request based on the information you have provided. Accordingly, I have determined that the Police Service of Northern Ireland does not hold the information to which you seek access.

In PSNI we do not have dedicated schools officers who work solely or even mainly with schools. We rather have Local Policing Teams and Neighbourhood Policing Teams whose officers provide a number of hours Citizenship and Safety Education (CASE) engagement with schools in their area.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
