Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Answer

There is no policy regarding reporting misconduct/disciplinary hearings. The results of misconduct/disciplinary hearings are not publically reported regardless of the nature of the allegation. Request 7

What is your policy on reporting restrictions for misconduct/disciplinary hearings for your officers who are accused of sexual misconduct and/or sexual assault?

Answer

There is no policy regarding reporting misconduct/disciplinary hearings. The results of misconduct/disciplinary hearings are not publically reported regardless of the nature of the allegation. Current discipline regulations (Police (Conduct) Regulations (Northern Ireland) 2016) do not legislate for public reporting.

Request 8

What is your policy for victims discussing misconduct hearings when a case is been heard. Are victims prohibited from speaking about misconduct trials to other parties after the hearing is concluded including when the officer is dismissed / suspended from their roles?

Answer

There is no policy regarding this matter. However any discussion of by any party (witness, panel etc.) regarding a misconduct hearing may be seen as a breach of the Code Of Ethics (Article 3 Privacy and Confidentiality).

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
