Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold some information to which your request relates. The decision has been taken to disclose the following.

Request 1

How many disability hate crimes have been recorded by your police force for the last two financial years –2019/20 and 2020/21?

Request 3

How many disability hate crimes during each financial year (2019/20 and 2020/21) concerned acts of violence against a person?

Request 4

How many incidents of disability hate crime were recorded as taking place online in each financial year (2019/20 and 2020/21)?

Answers 1, 3 and 4

Please note: This information is based on data extracted from a live system and may be subject to change. It is dependent on the information having been input into the system in such a way as to identify those records that are relevant.

Request 2

How many disability hate crimes were committed by repeat offenders (of a previous disability hate crime) in the last two financial years- 2019/20 and 2020/21?

Answer

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act and we can confirm that the Police Service of Northern Ireland does not hold information in relation to your request.

PSNI records hate crime motivations on the database at the occurrence level; however the database does not link directly to a suspect or the offences they have committed. Whilst PSNI can review an

occurrence as a whole and indicate whether hate crime was involved, unfortunately we cannot determine if individual suspects within an occurrence are deemed to have committed a hate crime.

Accordingly, we have determined that the Police Service of Northern Ireland does not hold the information to which you seek access.

How many of the recorded disability hate crimes in each financial year (2019/20 and 2020/21) resulted in a PPS referral?

Request 6

How many of the recorded online disability hate crimes in each financial year (2019/20 and 2020/21) resulted in a PPS referral?

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
