Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Clarification sought

Can you please confirm the City you require the Data for?

Can you specify the time frame for the data i.e. 1/1/15 to 1/1/20, as there may be a number of reports over a 5 year period?

You have asked for 'accident data'. Can you please specify the type of accident i.e. All RTC's, Injury Only RTC's etc.

Clarification received

We require data for Enniskillen.

18/08/2015 to 18/08/2020 is ideally what we require but I understand the data you hold may be less recent. If so please could we have 60 months from the latest data that you have data for. We require injury only accident data

Request

Please can we have accident data for a 60 month period, from the latest report you have.

Please could we have the data for the area shown in the attached plan (BT74 6HJ).

Please could we have as much of the following data as is possible:

- Plot of accident locations ·
- Date and time (Over a period of the last available 60 months)
- Weather and Lighting Conditions ·
- Number and type of vehicles involved ·
- Severity (Slight, Serious, Fatal) - (we only need injury accidents) ·
- An OS Grid reference ·
- Brief Description of what occurred ·
- And anything else you feel relevant.

Answer

Please see the information requested in the separate excel spreadsheet labelled 'Collision history – outline area Enniskillen' from 1st April 2015 – 31st March 2020.

Please note that PSNI only produce statistics for collision and casualty information in relation to collisions in which an injury occurred and which were reported to police.

Due to ongoing validating the information provided may be subject to change.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible or in any case within two months of the date of issue of this letter. In the event that you require a review to be undertaken, you can do so by writing to the Head of Corporate Information Branch, PSNI Headquarters, 65 Knock Road, Belfast, BT5 6LE or by emailing foi@psni.pnn.police.uk.

If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
