# Please note the following:

Career Breaks can be extended, and where an officer is currently on a career break, the length of their career break has only been calculated to the 30th September 2020.

There are a small number of exceptional cases where a career break exceeds the maximum 5 year period. This is rare and is a case by case basis where exceptional circumstances may affect the return to work such as but not limited to vetting clearance or fitness to return to work.

### **Request 3**

What training did they have to avail of on their return to work and were they submitted to any sort of probationary period?

### Answer

We can confirm that the Police Service of Northern Ireland does not hold information in relation to your request. Enquiries made in relation to your request failed to locate any records or documents relevant to your request based on the information you have provided.

This information is not recorded or held on the database and is not required to be within the remit of the Career Break and Unpaid Leave Policy.

Accordingly, I have determined that the Police Service of Northern Ireland does not hold the information to which you seek access.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
