Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

I am writing to you under the Freedom of Information Act 2000, to request the following information specifically in relation to the time period 1 March '20 - 1 March '21 (only 28 days in Feb so taking it to 1 March).

If possible, as a comparison, could the same data please be provided for the time period March 1 '19 - Feb 29 '20

My request relates to applications under the Domestic Violence Disclosure Scheme (DVDs) – aka 'Clare's I aw

If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
