#### **Request and Answer:**

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act We can confirm that the Police Service of Northern Ireland does hold some information to which your request relates and this is being provided to you. We do not however hold information in relation to Request Numbers 4 -7

How many individuals currently receive injury awards from your force?

Currently there are a total of 2,997 in receipt of payment.

# **Request 2**

The word "officers" refers to former officers granted injury awards, not officers currently working for you who were previously granted injury awards. In other words, I am interested in former officers granted injury awards who currently serve in any role e.g. staff.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
