How many times has the PSNI declared a critical incident in each of the last 5 years (2017-2022)?

Critical incident is defined as 'Any incident, where the effectiveness of the police response is likely to have a significant impact on the confidence of the victim, their family and / or the community'.

Please provide the number per year and reason for each occasion.

Answer

The PSNI have declared 26 critical incidents in the last five years (2017-2022).
