### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

## Request 1

A breakdown of the number of registered sex offenders in Northern Ireland and the areas in which they live, showing the number in each geographical location, i.e. by major town/ city district (i.e. South Belfast, West Belfast etc.) or counties.

# Request 2

Also the number who are in the highest risk category (Category 3 I believe) and the number who are men and women.

#### **Answer**

There are currently three "Category 3" Registered Sex Offenders in the community. In total there are 7 female RSOs out of a total of 1590 in the community, the remainder are all male.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
