Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold the information to which your request relates and this is being provided to you. The decision has been taken to disclose the following.

Request Number 1

The number of police officers that have been investigated for their conduct in text messages, on WhatsApp and/or other social media sites in the calendar years of 2017, 2018, 2019, 2020, 2021 and available information for 2022.

Answer

The following number of officers have been investigated by PSNI for allegations of misconduct relating to text messages and use of social media:

2017 – 6 Officers

2018 - 6 Officers

2019 - 15 Officers

2020 - 34 Officers

2021 - 12 Officers

2022 (to date) - 13 Officers

It should be noted that some investigations may have involved multiple officers, therefore the number of officers investigated will not necessarily equate to the number of incidents reported to PSNI.

If, following an Internal Review carried out by an independent decision maker, you remain dissatisfied with the handling of your request, you may make a complaint to the Information Commissioner's

Office, under Section 50 of the Freedom of Information Act, and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
