# FREEDOM OF INFORMATION REQUEST

Subject: Covid 19 Testing

#### **Request and Answer:**

Your request for information below has now been considered. In respect of Section 1(1)(a) of the Freedom of Information Act 2000 (FOIA) we can confirm that the Police Service of Northern Ireland does hold the information you have requested however it is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. We have explained to you below that when PSNI estimates whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if certain conditions are met. In this case those conditions are met and complying with all of your requests would in our estimation exceed that appropriate limit set out in Regulation. We have explained this further below but also we followed the Information Commissioner's Office guidance '*Requests where the cost of compliance exceeds the appropriate limit*' in relation to this request, which also provides further detail on the application of section 12 (1) of the FOIA. **Request 1** How many officers have tested positive for Covid?

## Request 2

How many officers have isolated after a positive Covid test?

#### Request 3

How many officers have isolated but didn't test positive for Covid

#### **Request 4**

How many officers have self-isolated yet didn't get tested for Covid or had not been near anyone who had Covid?

## Request 5

How many officers died as a result of Covid? I hope there wasn't any.

## **Request 6**

What communication was sent out to the force about the Covid test and trace app?

## **Request 7**

If officers where advised not to, what were the operational reasons for not downloading?

## **Request 8**

A copy of all correspondence from the Department of Health and Public Health Agency relating to Covid?

#### Answer

Enquiries made in relation to your request has identified that retrieval of all information would exceed the 18 hour cost limit, set by the Secretary of State under the FOI Act.

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. Section 12 of FOIA allows a public authority to refuse to deal with a request where it estimates that it would exceed the appropriate limit to either comply with the request in its entirety or confirm or deny whether the requested information is held. The estimate must be reasonable in the circumstances of the case. The 'appropriate limit' is currently £600 for central government and £450 for all other public authorities including PSNI. The relevant Regulations which define the appropriate limit for section 12 purposes are The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244. These are known as the 'Fees Regulations' for brevity.

Regulation 4(3) of the Fees Regulations states that a public authority can take into account the costs it reasonably expects to incur in carrying out the following permitted activities in complying with the request:

(i) determining whether the information is held;

- (ii) locating the information, or a document containing it;
- (iii) retrieving the information, or a document containing it; and
- (iv) extracting the information from a document containing it.

Under those regulations PSNI can calculate the time spent on each of these permitted activities at  $\pounds 25$  per hour (thus if the activity(s) takes more than 18 hours PSNI will be in excess of the 'appropriate limit').

When a public authority is estimating whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if the conditions laid out in Regulation 5 of the Fees Regulations can be satisfied. Those conditions require the requests to be:

- made by one person, or by different persons who appear to the public authority to be acting in concert or in pursuance of a campaign;
- made for the same or similar information; and
- received by the public authority within any period of 60 consecutive working days.

Regulation 5(2) of the Fees Regulations requires that the requests which are to be aggregated relate *"to any extent"* to the same or similar information. This is quite a wide test but public authorities

should still ensure that the requests meet this requirement.

The requested information is not held centrally and therefore it was necessary to consult with various business areas across PSNI.

In relation to Request 8, a number of staff within one particular business area would be liaising with the Department of Health and Public Health Agency. Correspondence could be filed under a subject rather than correspondence between DoH and/or PHA. For that reason a manual trawl of all correspondence would be required to ascertain if it related to DoH and/or PHA with regard to Covid.

One staff member within this business area has approximately 97 folders/sub folders, with each folder containing 1 - 200 e-mails. In addition there are numerous folders held electronically by other staff members in this branch and by way of an example 1 folder alone contains 3,000 items.

Although difficult to quantify, on these examples alone, estimating a minimum of 1 minute to examine each item and average 10 e-mails per folder/subfolder (even though there are likely up to 200 e-mails per folder) then this would equate to approximately 100 hrs, grossly exceeding the 18 hour cost limit.

This estimate would be further increased to retrieve correspondence by colleagues in other business areas who may hold relevant information.

Under Section 12 of the Freedom of Information Act 2000, if any part of the request exceeds the cost threshold then the whole request will be excess costs and there is no obligation to answer any part of the request.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice and the request has therefore been closed.

#### Advice and Assistance

Under section 16 of the FOIA, PSNI will always try to assist you to refine your request and provide advice where we can. PSNI has considered how your request may be refined to bring it under the appropriate limit.

Subject to any relevant exemptions, it may be possible to retrieve the following information within the appropriate cost limit :

#### Request 1 – 7

Request 8 - As some PHA/DoH correspondence may be held by some staff on a subject basis, if the request could be narrowed down to a particular subject rather than all correspondence then a smaller timeframe may result in the outcome.

Submission of a refined request would be treated as a new request and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant exemptions at Part 2 of the FOIA.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible or in any case within two months of the date of issue of this letter. In the event that you require a review to be undertaken, you can do so by writing to the Head of Corporate Information Branch, PSNI Headquarters, 65 Knock Road, Belfast, BT5 6LE or by emailing foi@psni.pnn.police.uk.

If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
