Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland (PSNI) does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

I am writing to you under the Freedom of Information Act 2000 to request the following information relating to tool theft in the period 2011-2022. If this period is too extensive can this be provided for 2017-2022 inclusive. I require this information in calendar years.

How many crimes have been reported regarding tool theft, including theft of a vehicle containing tools?

Request 2

What was the reported value of the tools stolen each year?

I confirm that I am content to receive a total yearly figure only as recorded in the 'Original Value' and 'Current Value' columns from your data.

Answers 1 – 2

Please see the response provided in the table below:

The table provided below is based on all recorded burglary, robbery and theft offences where property described as 'machinery or tools' was classified as 'stolen', during the period January 2011 - July 2022.

Please note in conjunction with the information the following caveats:

- (i) The information included in the table is based on data extracted from a live system and may be subject to change. It is dependent on the information having been input into the system in such a way as to identify those records that are relevant.
- (ii) The recorded monetary information has been calculated based only on the 'Original Value' and 'Current Value' fields on the central database, were they have been recorded.

(iii) Information regarding value of tools may have been entered into a 'Remarks' free text field within the central database. Some of the information held in these fields is personal information, not complete, nor is it consistently entered. The figures provided in the table do not include additional information that may have been contained within this 'Remarks' field.

How many of the tool theft cases reported led to prosecution?

Answer 3

A total of 405 cases led to prosecution.
