

# FREEDOM OF INFORMATION REQUEST

## Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

## Request 1

Can you please advise what date the PSNI changed from using Wooden Blocks to Baton Rounds as Missiles in Public Order Training?

## **Answer**

The PSNI changed from using wooden blocks to baton rounds as missiles in public order training in November 2013.

## Request 2

In the 5 years immediately preceding the change to Baton Rounds please confirm the following:

#### Request 2a

The number of Officers involved in Training.

## Answer

Level 1 trained between 2008 to 2013 = 1993 Level 2 trained between 2008 to 2013 = 5443

Level 1 training is annually and Level 2 training is every 3 years as per national guidelines.

### Request 2b

The number of Injuries occurring as a result of the Wooden Blocks during Public Order Training.

### **Answer**

The total number was 52.

### Note

A search was carried out of all electronic accident forms (e23/10s) submitted for the period 1 November 2008 to 31 October 2013. The parameters used are as follows, 'Nature Of Duty' selected as 'Training – Public Order', 'Training – Other' and 'Other'. There results were then analysed against

key words of Baton, Rounds, Missile, AEP, and Wood & Block. Once applied, the final total is 52 incidents reported, and all reported as 'Injury'.

## Request 3

In the 5 years after the change to Baton Rounds please confirm the following:

# Request 3a

Number of Officers involved in Training.

#### Answer

Level 1 trained between 2013 – 2018 = 1663 Level 2 trained between 2013 – 2018 = 5950

Level 1 training is annually and Level 2 training is every 3 years as per national guidelines.

## Request 3b

Number of Officers injured by Baton Rounds during Public Order Training.

#### **Answer**

The total number was 32.

#### Note

A search was carried out of all electronic accident forms (e23/10s) submitted for the period 1 November 2013 to 31 October 2018. Again the parameters used as follows, 'Nature of Duty' selected as 'Training – Other' and 'Other'. These results were then analysed against key words of Baton, Rounds, Missile, & AEP. Once applied, the final total is 34 incidents reported. 32 reported as 'Injury' and 2 reported as a 'Near Miss'.
