Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request

Keith had been contacted by a constituent who had recently been in an accident at these crossroads on the Kiltyclogher Road.

Keith was enquring as to how many accidents have occurred there

(i) in the past year,

(ii) past 5 years and

(iii) and past 10 years?

Clarification

I have attached a map screenshot of the area in question. It is the crossroads at Kitlyclay Road and Kitlyclogher Road.

Any information regarding to accidents reported to the police will be helpful.

Answer

The accounting period 1st June 2012 to 31st May 2022 has returned a NIL figure for reported injury road traffic collisions at Kiltyclogher Road / Kiltyclay Road / Gortacar Road junction, Cookstown. Please note:

- This data relates to collisions where an injury was involved and reported to Police.
- The PSNI Statistics Branch do not collect data on damage only collisions.
