Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

Do you currently anticipate a recruitment drive for student police officers in 2023?

Answer

The Police Service of Northern Ireland does not currently anticipate launching a Student Officer recruitment campaign in 2023.

Request 1A

If so when will this decision be made?

Answer

Request 1B

When will this campaign be advertised?

Answer

Request 2

Is there a maximum amount of time you can have between recruitment drives?

Answer

No. The timing of our recruitment campaigns is based on a range of factors including our workforce resourcing plan, the number of candidates remaining in the recruitment pipeline and budgetary considerations.

Request 3

What is the current longest time you have had between recruitment drives since the PSNI was formed?

Answer

The longest gap between Student Officer campaigns has been 3 years 9 months (January 2010 to September 2013).

Request 4

Has the gap in PSNI budget for recruitment been corrected?

Answer

The Police Service of Northern Ireland continues to face significant budgetary pressures impacting the number and timing of Student Officer appointments.
