Subject: Foreign National Incidents in the Dungannon area

Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act I can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

The number of incidents which have resulted in arrests.

Answer

There were 11 incidents relating to foreign nationals.

Request 2

The charges which have been brought against foreign nationals over the past 6 months in the Milltown, Moygashell and Dungannon town centre.

Answer

The 11 incidents which have resulted in persons being charged, for the six month period up to 18th September 2021. The offences in which the charges have been prepared are as follows, it should be noted that individuals could be charged with one or more of the offences detailed and one or more offences could refer to the same incident.

1 x Criminal Damage

1 x GHB with Intent

4 x Driving with excess alcohol

If, following an Internal Review carried out by an independent decision maker, you remain dissatisfied with the handling of your request, you may make a complaint to the Information Commissioner's Office, under Section 50 of the Freedom of Information Act, and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
