# FREEDOM OF INFORMATION REQUEST

Subject: Sex Crime Statistics

#### Request and Answer:

Your request for information below has now been considered. In respect of Section 1(1)(a) of the Freedom of Information Act 2000 (FOIA) we can confirm that the Police Service of Northern Ireland does hold the information you have requested however it is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. We have explained to you below that when PSNI estimates whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if certain conditions are met. In this case those conditions are met and complying with all of your requests would in our estimation exceed that appropriate limit set out in Regulation. We have explained this further below but also we followed the Information Commissioner's Office guidance '*Requests where the cost of compliance exceeds the appropriate limit*' in relation to this request, which also provides further detail on the application of Section 12 (1) of the FOIA. You requested the following information from PSNI:

Request Numbers 1 and 2 from request number F-2021-02152, will be answered separately to this request as previously notified. Please see below remaining questions and answers as requested.

For each calendar year: 2018, 2019, 2020; and 01/01/2021 to 09/09/2021.

The number of stalking offences reported which resulted in no further action being taken.

#### **Request 1B**

The number of stalking offences reported which resulted in further action being taken, including but not limited to arrests, charges, summons etc.

The number of rape offences reported which resulted in no further action being taken.

The number of sexual assault/violence offences reported which resulted in no further action.

## Answers

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. Section 12 of FOIA allows a public authority to refuse to deal with a request where it estimates that it would exceed the appropriate limit to either comply with the request in its entirety or confirm or deny whether the requested information is held. The estimate must be reasonable in the circumstances of the case. The 'appropriate limit' is currently £600 for central government and £450 for all other public authorities including PSNI. The relevant Regulations which define the appropriate limit for section 12 purposes are The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244. These are known as the 'Fees Regulations' for brevity.

Regulation 4(3) of the Fees Regulations states that a public authority can take into account the costs it reasonably expects to incur in carrying out the following permitted activities in complying with the request:

- (i) determining whether the information is held;
- (ii) locating the information, or a document containing it;
- (iii) retrieving the information, or a document containing it; and
- (iv) extracting the information from a document containing it.

Under those regulations PSNI can calculate the time spent on each of these permitted activities at £25 per hour (thus if the activity(s) takes more than 18 hours PSNI will be in excess of the 'appropriate limit').

PSNI have no specific offence code regarding 'sexual harassment', therefore to answer Request numbers 4 and 4B of the request would involve a manual trawl of all harassment offences on the PSNI database to ascertain if there was a sexual element to the harassment offence. PSNI have more than 31,500 offences recorded in the time period requested, allowing ten minutes per record would equate to more than 5,250 hours, grossly exceeding the legislative timescale as set by the Secretary of State. If the time period was reduced, within the most recent 12 month period (October 2020 -September 2021), there have been more than 13,000 harassment offences recorded, which would equate to approximately 2,166 hours. Furthermore, depending on how 'sexual harassment' is defined, the circumstances of the offence may result in a sexual assault offence being recorded adding to this result. These requests grossly exceed the FOI legislative cost of 18 hours as set by the Secretary of State.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice, and the request has therefore been closed.

#### Advice and Assistance

You may wish to submit a refined request in order that the cost of complying with your request may be facilitated within the 'appropriate limit'. In compliance with Section 16 of the Act, we have considered how your request may be refined to bring it under the appropriate limit and can advise as follows:

- Request 1 and 1 B PSNI can advise at present, there is no specific offence of stalking within Northern Ireland. Therefore accordingly, we have determined that the Police Service of Northern Ireland does not hold the information to which you seek access.
- Request 2 PSNI can provide the number of rapes offences reported to police and the outcome that has since been assigned to that offence.
- Request 3 PSNI can provide the number of sexual assault offences reported to police and the outcome that has since been assigned to that offence.

Submission of a refined request would be treated as a new request, and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant Part II exemptions.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible or in any case within two months of the date of issue of this letter. If, following an Internal Review carried out by an independent decision maker, you remain dissatisfied with the handling of your request, you may make a complaint to the Information Commissioner's Office, under Section 50 of the Freedom of Information Act, and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
