

# FREEDOM OF INFORMATION REQUEST

Subject: PSNI Staff

#### Request and Answer:

Your request for information below has now been considered. In respect of Section 1(1)(a) of the Freedom of Information Act 2000 (FOIA) we can confirm that the Police Service of Northern Ireland does hold the information you have requested however it is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. We have explained to you below that when PSNI estimates whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if certain conditions are met. In this case those conditions are met and complying with all of your requests would in our estimation exceed that appropriate limit set out in Regulation. We have explained this further below but also we followed the Information Commissioner's Office guidance 'Requests where the cost of compliance exceeds the appropriate limit' in relation to this request, which also provides further detail on the application of section 12 (1) of the FOIA. # Request 1

I wish to request the following information. In each case figures at 1/6/2020 are requested. If not possible please use current figures.

How many staff (i.e non-police) did PSNI have i.e actual people as opposed to full time equivalents (FTE)? Please exclude agency staff and anyone not employed under normal PSNI/NICS terms and conditions.

#### Request 2

How many of the numbers at 1 were female and how many were male?

#### Request 3

How many staff were there in PSNI HR Dept (not FTE) and how many of these were female and how many were male?

#### Request 4

How many staff in PSNI were partially retired at 1/6/2020 and of these how many were female and

how many were male?

### Request 5

How many staff in HR Dept were partially retired at 1/6/2020 and of these how many were female and how many were male?

## Request 6

In the last 5 years how many staff in PSNI have been refused partial retirement and how many of these were female and how many were male?

# Request 7

In the last 5 years how many staff in HR have been refused partial retirement and how many of these were female and how many were male?

#### **Answer**

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. Section 12 of FOIA allows a public authority to refuse to deal with a request where it estimates that it would exceed the appropriate limit to either comply with the request in its entirety or confirm or deny whether the requested information is held. The estimate must be reasonable in the circumstances of the case. The 'appropriate limit' is currently £600 for central government and £450 for all other public authorities including PSNI. The relevant Regulations which define the appropriate limit for section 12 purposes are The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244. These are known as the 'Fees Regulations' for brevity.

Regulation 4(3) of the Fees Regulations states that a public authority can take into account the costs it reasonably expects to incur in carrying out the following permitted activities in complying with the request:

- (i) determining whether the information is held;
- (ii) locating the information, or a document containing it;
- (iii) retrieving the information, or a document containing it; and
- (iv) extracting the information from a document containing it.

Under those regulations PSNI can calculate the time spent on each of these permitted activities at £25 per hour (thus if the activity(s) takes more than 18 hours PSNI will be in excess of the 'appropriate limit').

When a public authority is estimating whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if the conditions laid out in Regulation 5 of the Fees Regulations can be satisfied. Those conditions require the requests to be:

- made by one person, or by different persons who appear to the public authority to be acting in concert or in pursuance of a campaign;
- made for the same or similar information; and
- received by the public authority within any period of 60 consecutive working days.

Regulation 5(2) of the Fees Regulations requires that the requests which are to be aggregated relate *"to any extent"* to the same or similar information. This is quite a wide test but public authorities

should still ensure that the requests meet this requirement.

Enquiries made in relation to your request has identified that retrieval of all requested information would exceed the 18 hour cost limit, set by the Secretary of State under the FOI Act.

In relation to Request 7, as these records are not recorded centrally and with staff turnover in the 5 year period, retrieval of any relevant information would require a trawl of each HR staff member's personnel file. This would include checking a minimum of 140 active personnel files along with any staff that have transferred out of HR department or left the organisation in the last 5 years. Although difficult to quantify, it is estimated to take an average of 10 minutes per file and this retrieval process would greatly exceed the 18 hour limit.

Partial retirements are progressed by the applicant, their line management and Civil Service Pensions. Under the current policy PSNI Human Resources only record when the application is approved and are not notified of declined or deferred applications. Therefore, in relation to Request 6, a similar retrieval process would be required by each district and department, further exceeding the appropriate cost limit. The retrieval process estimate would be further increased to respond to the remainder of your requests.

Under Section 12 of the Freedom of Information Act 2000, if any part of the request exceeds the cost threshold then the whole request will be excess costs and there is no obligation to answer any part of the request.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice and the request has therefore been closed.

#### **Advice and Assistance**

Under section 16 of the FOIA, PSNI will always try to assist you to refine your request and provide advice where we can. PSNI has considered how your request may be refined to bring it under the appropriate limit. Subject to any relevant exemptions, it may be possible to retrieve the following information within the appropriate cost limit.

Request 1 – 5

Submission of a refined request would be treated as a new request and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant exemptions at Part 2 of the FOIA.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible or in any case within two months of the date of issue of this letter. If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they

investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
