Of the orders obtained, PSNI determined that a total of four to be in default with enforcement action being taken or considered.

Value of funds recovered through confiscation orders.

Answer

Please see below information regarding value of funds recovered from confiscation orders for time period requested:

- 2017/2018 20 orders obtained total value £462,594.09
- 2018/2019 15 orders obtained total value £602,664.71
- 2019/2020 12 orders obtained total value £1,343,642.17
- 2020/2021 14 orders obtained total value £499,795.97
