## FREEDOM OF INFORMATION REQUEST

**Keyword:** Crime

**Subject:** Fireworks In 2020

### Request and Answer:

Your request for information below has now been considered. In respect of Section 1(1)(a) of the Freedom of Information Act 2000 (FOIA) we can confirm that the Police Service of Northern Ireland does hold the information you have requested however it is estimated that the cost of complying with your request for information would exceed the “appropriate costs limit” under Section 12(1) of the Freedom of Information Act 2000. We have explained to you below that when PSNI estimates whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if certain conditions are met. In this case those conditions are met and complying with all of your requests would in our estimation exceed that appropriate limit set out in Regulation. We have explained this further below but also we followed the Information Commissioner’s Office guidance *‘Requests where the cost of compliance exceeds the appropriate limit’* in relation to this request, which also provides further detail on the application of section 12 (1) of the FOIA. You requested the following information from PSNI:

#### Request 1

How many domestic fireworks licenses where applied for in 2020 up to and including 31st October

#### Request 2

How many domestic fireworks licenses where approved in 2020 up to and including 31st October

#### Request 3

How many domestic fireworks licenses where refused in 2020 up to and including 31st October

#### Request 4

How many PSNI search operations were conducted to find or disrupt the sale of illegal fireworks in 2020 up to and including 31st October

#### Request 5

How many illegal fireworks were seized up to and including 31st October

### **Request 6**

How many arrests were made for the illegal display of fireworks in 2020 up to and including 31st October

### **Request 7**

How many arrests were made for the illegal sale in fireworks in 2020 of up to and including 31st October

### **Request 8**

How many 101 calls were made to report either licensed or unlicensed displays of fireworks in 2020 up to and including 31st October

### **Answer**

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the “appropriate costs limit” under Section 12(1) of the Freedom of Information Act 2000. Section 12 of FOIA allows a public authority to refuse to deal with a request where it estimates that it would exceed the appropriate limit to either comply with the request in its entirety or confirm or deny whether the requested information is held. The estimate must be reasonable in the circumstances of the case. The ‘appropriate limit’ is currently £600 for central government and £450 for all other public authorities including PSNI. The relevant Regulations which define the appropriate limit for section 12 purposes are The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244. These are known as the ‘Fees Regulations’ for brevity.

Regulation 4(3) of the Fees Regulations states that a public authority can take into account the costs it reasonably expects to incur in carrying out the following permitted activities in complying with the request:

- (i) determining whether the information is held;
- (ii) locating the information, or a document containing it;
- (iii) retrieving the information, or a document containing it; and
- (iv) extracting the information from a document containing it.

Under those regulations PSNI can calculate the time spent on each of these permitted activities at £25 per hour (thus if the activity(s) takes more than 18 hours PSNI will be in excess of the ‘appropriate limit’).

When a public authority is estimating whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if the conditions laid out in Regulation 5 of the Fees Regulations can be satisfied. Those conditions require the requests to be:

- made by one person, or by different persons who appear to the public authority to be acting in concert or in pursuance of a campaign;
- made for the same or similar information; and
- received by the public authority within any period of 60 consecutive working days.

Regulation 5(2) of the Fees Regulations requires that the requests which are to be aggregated relate “to any extent” to the same or similar information. This is quite a wide test but public authorities should still ensure that the requests meet this requirement.

Enquiries made in relation to your request 4 and 8 identified that retrieval of the information would exceed the 18 hour cost limit set under the FOI Act, by the Secretary of State.

In regard to Request 4 inquiries were made for the period of the 1 January 2020 to 31 October 2020, there were 1,965 search occurrences recorded. Each occurrence would require a manual trawl to identify if the search was in relation to Fireworks. With an estimated 5 minutes per occurrence this would take in excess of 163 hours.

In regard to Request 8, this information is not held in an easily accessible search format. To give an indication of the size a word search was done using the word 'fireworks' contained in either the primary form or the log of any incident created during October of 2020. This is only one month and it gave a result of 2,099 incidents. Allowing approximately 5 minutes to read each incident would take approximately 174 hours.

**Under Section 12 of the Freedom of Information Act 2000, if any part of the request exceeds the cost threshold then the whole request will be excess costs and there is no obligation to answer any part of the request.**

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice, and the request has therefore been closed.

### **Advice and Assistance**

Under section 16 of the FOIA, PSNI will always try to assist you to refine your request and provide advice where we can. PSNI has considered how your request may be refined to bring it under the appropriate limit.

Subject to any relevant exemptions, it may be possible to retrieve information in relation to Request 5, 6 and 7 within the appropriate cost limit.

Please note in relation to requests 1, 2 and 3 the PSNI does not hold this information, you should therefore direct these requests to the Department of Justice who deal in the matter of Firework Licenses.

Submission of a refined request would be treated as a new request, and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant Part II exemptions.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible or in any case within two months of the date of issue of this letter. In the event that you require a review to be undertaken, you can do so by writing to the Head of Corporate Information Branch, PSNI Headquarters, 65 Knock Road, Belfast, BT5 6LE or by emailing [foi@psni.pnn.police.uk](mailto:foi@psni.pnn.police.uk).

If following an internal review, carried out by an independent decision maker, you were to remain dissatisfied in any way with the handling of the request you may make a complaint, under Section 50 of the Freedom of Information Act, to the Information Commissioner's Office and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. You can write to the Information Commissioner at Information Commissioner's Office, Wycliffe House, Water Lane, Wilmslow, Cheshire, SK9 5AF. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however

the Commissioner has the option to investigate the matter at his discretion.
