#### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates and the decision has been taken to disclose the following.

# Request 1

Based on refinement offered in previous FOI F-2020-02177 - the number of offences by crime type where the Modus Operandi (MO) location was input as school or college. School location identified from the location MO indicates an offence occurred at or within the vicinity of school or college premises.

Please state how many crimes took place on school premises on each of the last three years.

# Request 2

In each year, please provide a breakdown of the type of crime.

#### Answer

Please see the table below based on all recorded offences where the location was either 'School' or 'College', during the period 2018 to 2020. This is broken down by year and by the offence classification.

### The following notes are applicable to the data provided.

The 'school' and 'college' location subtypes indicates that an offence occurred at or within the vicinity of school or college premises. Therefore, the offence may have occurred outside of school or college premises. Additionally, the offences may have occurred on school premises outside of school hours and those involved in the offence may not have any connection to the school.

This information is based on data extracted from a live system and may be subject to change. It is dependent on the information having been input into the system in such a way as to identify those records that are relevant.

In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
