Subject: Crime Report Statistics 2017 - 2021

Request and Answer:

Your request for information below has now been considered. In respect of Section 1(1) (a) of the Freedom of Information Act 2000 (FOIA) we can confirm that the Police Service of Northern Ireland does hold the information you have requested however it is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000.

We have explained to you below that when PSNI estimates whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if certain conditions are met. In this case those conditions are met and complying with all of your requests would in our estimation exceed that appropriate limit set out in Regulation. We have explained this further below but also we followed the Information Commissioner's Office guidance 'Requests where the cost of compliance exceeds the appropriate limit' in relation to this request, which also provides further detail on the application of Section 12 (1) of the FOIA. You requested the following information from PSNI:

Request 1

For the years 2017, 2018, 2019, 2020, and 2021 how many crime reports were received in each year?

Request 2

Of those crime reports, how many were categorised under the following offences?

- a. Rape
- b. Other sexual offences
- c. Violence with injury
- d. Violence without injury
- e. Homicide
- f. Stalking and Harassment
- g. Hate crimes

Request 3

For the above crime reports, how many resulted in a successful prosecution?

Request 4

For the years 2017, 2018, 2019, 2020, and 2021 how many crime reports involved a victim with 'sexual orientation' as a protected characteristic in each year?

Request 5

Of those reports which involved a victim with 'sexual orientation' as a protected characteristic, how many were categorised under the following offences?

- a. Rape
- b. Other sexual offences
- c. Violence with injury
- d. Violence without injury
- e. Homicide
- f. Stalking and Harassment
- g. Hate crimes

Request 6

For the above crime reports, how many resulted in a successful prosecution?

Answer

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. Section 12 of FOIA allows a public authority to refuse to deal with a request where it estimates that it would exceed the appropriate limit to either comply with the request in its entirety or confirm or deny whether the requested information is held. The estimate must be reasonable in the circumstances of the case. The 'appropriate limit' is currently £600 for central government and £450 for all other public authorities including PSNI. The relevant Regulations which define the appropriate limit for section 12 purposes are The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244. These are known as the 'Fees Regulations' for brevity.

Regulation 4(3) of the Fees Regulations states that a public authority can take into account the costs it reasonably expects to incur in carrying out the following permitted activities in complying with the request:

- (i) determining whether the information is held;
- (ii) locating the information, or a document containing it;
- (iii) retrieving the information, or a document containing it; and
- (iv) extracting the information from a document containing it.

Under those regulations PSNI can calculate the time spent on each of these permitted activities at £25 per hour (thus if the activity(s) takes more than 18 hours PSNI will be in excess of the 'appropriate limit').

Enquiries made in relation to your request have identified that retrieval of this information would exceed the 18 hour cost limit set under the FOI Act by the Secretary of State. This information is not held in a retrievable format that provides the information without manual intervention, there are around 100,000 recorded offences each year, so for a five year period as requested there would be roughly half a million offences. Whilst the records may be extracted from the PSNI database each record may need to be manually checked to make sure that any case file/court details are connected appropriately to the offence recorded. Crime recording is an administrative exercise and is separate

from how crimes are investigated and case files compiled and so there is not a strictly one-to-one relationship between the two. Allowing 10 minutes to review each individual incident would grossly exceed the legislative timescale of 18 hours.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice, and the request has therefore been closed.

This spreadsheet provides a breakdown for all available offence classifications, except for 'hate crimes'. Information on the number of recorded crimes with a hate motivation, for each financial year from 2004/05 to 2020/21, can be found in the spreadsheets accompanying our latest Trends in Hate Motivated Incidents and Crimes Recorded by the Police in Northern Ireland annual bulletin, which can be found here:

Each of the six hate strands has its own spreadsheet.

For questions 4 and 5, all victims of crime will presumably have a sexual orientation. This label is equivalent to our 'homophobic' motivation. Information on crimes with a homophobic motivation from 2004/05 to 2020/21 is available in the Homophobic motivations spreadsheet associated with the Annual Trends in Hate Motivated Incidents and Crimes Recorded by the Police in Northern Ireland bulletin mentioned above, which can be found here:

You may wish to submit a refined request in order that the cost of complying with your request may be facilitated within the 'appropriate limit'. In compliance with Section 16 of the Act, we have considered how your request may be refined to bring it under the appropriate limit however unfortunately on this occasion PSNI are unable to provide any refinement for this request.

Submission of a refined request would be treated as a new request, and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant Part II exemptions.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. You should do this as soon as possible or in any case within two months of the date of issue of this letter. If, following an Internal Review carried out by an independent decision maker, you remain dissatisfied with the handling of your request, you may make a complaint to the Information

Commissioner's Office, under Section 50 of the Freedom of Information Act, and ask that they investigate whether the PSNI has complied with the terms of the Freedom of Information Act. In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
