### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland (PSNI) does hold information to which your request relates. The decision has been taken to disclose the following.

### Request 1

How many candidates are on the merit list from the 2021 recruitment campaign?

#### Answer

There are a total of 1062 candidates on the 2021 Student Officer Campaign merit list for the PSNI.

#### Request 2

Have any candidates from the 2021 campaign yet begun their training?

#### **Answer**

No candidates who applied to the 2021 Student Officer Campaign have commenced the Student Officer Development Programme as yet.

## Request 3

When do you anticipate candidates from the 2021 campaign will begin their training?

## Answer

The timing of appointments to commence the Student Officer Development Programme will be determined by the available budget and operational demand. These factors are reviewed on a continual basis.

### Request 4

How many candidates do you expect to appoint from the merit list/what is the usual attrition rate?

### **Answer**

The number of appointments will be determined by the available budget and operational demand. The attrition rate with the merit pool varies across recruitment campaigns – the process of candidates within our 2018 and 2020 campaigns is available via Join PSNI | Recruitment News

### Request 5

How long do you anticipate it to take to work through the merit list?

#### **Answer**

The number and timing of appointments made from the 2021 Campaign merit list will be determined by the available budget and operational demand. These factors are reviewed on a continual basis.

### Request 6

What capacity are you currently operating at for training student officers? (%)

#### **Answer**

During the current financial year 2022/23 the PSNI will train 197 students (current plan). Recruitment numbers fluctuate on the basis of projected leavers per year.
