Request

In October 2021 the NPCC asked police forces to conduct reviews into handling of reports of domestic abuse / exposure / other VAWG related allegations involving police officers and staff.

 Please disclose to me, under the Freedom of Information Act, any findings / data / reports / reviews by your police force in response to this request from the NPCC.

Answer

Your request for information has now been considered. In respect of Section 1 (1) (a) of the Act we can confirm that the Police Service of Northern Ireland (PSNI) does not hold information in relation to your request. Enquiries made in relation to your request failed to locate any records or documents relevant to your request based on the information you have provided.

The PSNI did not provide any response in relation to the NPCC request of October 2021.

Advice from NPCC

 On 08 October 2021 Martin Hewitt (NPCC Chair) wrote to forces outlining key requirements in relation to vetting and professional standards and asking forces to conduct their own internal reviews. However, there was no request for forces to submit a return to the NPCC and no commitment from the NPCC to coordinate this. Attached to the letter was a messaging pack produced by NPCC communications team to be used by NPCC to inform stakeholder, government, political and media briefings as well as messaging into local communities. This FOI request does not capture this VAWG framework action.

Separate to this communication from Mr Hewitt was a subsequent action set out in the VAWG framework published in December 2021 which asked forces to review their VAWG misconduct cases and provide feedback on the learning and outcomes of the force independent reviews. VAWG will publish the outcome of their findings. This FOI request does not capture this VAWG framework action

If you are dissatisfied in any way with the handling of your request, you have the right to request a review.
