Subject: PSNI Fitness Test

Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

Please consider this a freedom of information request. My request relates to the fitness test that candidates undertake during the PSNI recruitment process.

How many candidates undertook the fitness test from the 1st of January 2022 to the current date?

Answer

Between 1st January 2022 and 28th September 2022 23 candidates undertook the initial Physical Competence Assessment (PCA), and 28 candidates undertook a PCA Retest.

Request 2

How many candidates passed the fitness test from the 1st of January 2022 to the current date?

Answer

Of the 23 candidates who undertook the initial PCA during this timeframe, 18 candidates passed. Of the 28 candidates who undertook a PCA Retest during this timeframe, 22 candidates passed.

Request 3

How many candidates failed the fitness test from the 1st of January 2022 to the current date?

Answer

Of the 23 candidates who undertook the initial PCA during this timeframe, 5 failed and were therefore required to undertake a PCA Retest. Of the 28 candidates who undertook a PCA Retest during this timeframe, 6 failed.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. In most circumstances, the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out however, the Commissioner has the option to investigate the matter at their discretion.
