# Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

# Request 1

How many student officers are due to commence training in the October intake?

### **Answer**

It is anticipated that 51 Student Officers will commence the Student Officer Development Programme in October 2022.

# Request 2

How many candidates will be remaining in the merit pool?

# Answer

179 candidates will remain on the 2020 Student Officer Campaign merit list following the October 2022 course. There are also a total of 1061 candidates remaining on the 2021 Student Officer Campaign merit list.

# Request 3

How many candidates are still progressing through the final stages before being considered appointable?

# **Answer**

50 candidates on the 2020 Student Officer Campaign merit list are still progressing through the PSNI managed stages, and are therefore not yet considered appointable. The 1061 candidates on the 2021 Student Officer Campaign merit list have not yet commenced the PSNI managed stages.

#### Request 4

How many candidates in total have withdrawn or not completed all PSNI managed stages?

#### Answer

327 candidates who applied to the 2020 Student Officer Campaign have withdrawn, or did not successfully complete all of the PSNI managed stages. 1 candidate who applied to the 2021 Student

Officer Campaign has withdrawn.
