



## FREEDOM OF INFORMATION REQUEST

**Keyword:** Policing Themes, Operations and Investigations Events and Public Order

**Subject:** Use of Force/First Aid in CPU

### Request and Answer:

Your request for information below has now been considered. In respect of Section 1(1)(a) of the Freedom of Information Act 2000 (FOIA) we can confirm that the Police Service of Northern Ireland does hold the information you have requested however it is estimated that the cost of complying with your request for information would exceed the “appropriate costs limit” under Section 12(1) of the Freedom of Information Act 2000. We have explained to you below that when PSNI estimates whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if certain conditions are met. In this case those conditions are met and complying with all of your requests would in our estimation exceed that appropriate limit set out in Regulation. We have explained this further below but also we followed the Information Commissioner’s Office guidance *‘Requests where the cost of compliance exceeds the appropriate limit’* in relation to this request, which also provides further detail on the application of section 12 (1) of the FOIA. You requested the following information from PSNI:

#### Request 1

How many Use of Force forms have been submitted in the last 5 years (if this costs too much reduce to 3 years) by CPU officers?

Please break down by category of force used - i.e. open hand, CS/PAVA, Baton, firearm drawn/pointed or firearm used.

#### Request 2

How many times in the last 5 years (again reduce to meet cost limits of FOI if necessary) have CPU officers used skills requiring knowledge obtained specifically through D13 first aid training? Actually administering first aid to a casualty, not just bringing out kit. IE - administering oxygen, eye gels, inflatable splints etc.

#### Answer

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate

limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the “appropriate costs limit” under Section 12(1) of the Freedom of Information Act 2000. Section 12 of FOIA allows a public authority to refuse to deal with a request where it estimates that it would exceed the appropriate limit to either comply with the request in its entirety or confirm or deny whether the requested information is held. The estimate must be reasonable in the circumstances of the case. The ‘appropriate limit’ is currently £600 for central government and £450 for all other public authorities including PSNI. The relevant Regulations which define the appropriate limit for section 12 purposes are The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244. These are known as the ‘Fees Regulations’ for brevity.

Regulation 4(3) of the Fees Regulations states that a public authority can take into account the costs it reasonably expects to incur in carrying out the following permitted activities in complying with the request:

- (i) determining whether the information is held;
- (ii) locating the information, or a document containing it;
- (iii) retrieving the information, or a document containing it; and
- (iv) extracting the information from a document containing it.

Under those regulations PSNI can calculate the time spent on each of these permitted activities at £25 per hour (thus if the activity(s) takes more than 18 hours PSNI will be in excess of the ‘appropriate limit’).

When a public authority is estimating whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if the conditions laid out in Regulation 5 of the Fees Regulations can be satisfied. Those conditions require the requests to be:

- made by one person, or by different persons who appear to the public authority to be acting in concert or in pursuance of a campaign;
- made for the same or similar information; and
- received by the public authority within any period of 60 consecutive working days.

Regulation 5(2) of the Fees Regulations requires that the requests which are to be aggregated relate “to any extent” to the same or similar information. This is quite a wide test but public authorities should still ensure that the requests meet this requirement.

Enquiries made in relation to your request have identified that the retrieval of information would exceed the 18 hour cost limit set by the Secretary Of State under the FOIA.

In relation to Request 1, the information requested is held electronically, however it is not held in a format that enables the data to be extracted without manual intervention. In order to quantify the records involved, the relevant business area has advised a senior officer would have to manually trawl through 130 officers files individually and each category for each officer individually in an attempt to retrieve the desired information. Additionally, the same process would be required for retired officers. It is estimated that due to the PSNI recording system this would take in excess of 18 hour cost limit.

**Under Section 12 of the Freedom of Information Act 2000, if any part of the request exceeds the cost threshold then the whole request will be excess costs and there is no obligation to answer any part of the request.**

In accordance with the Freedom of Information Act 2000, this letter should be considered as a

Refusal Notice, and the request has therefore been closed.

## **Advice and Assistance**

Under Section 16 of the FOIA PSNI will always try to assist you to refine your request and provide advice where we can. Unfortunately, as a manual trawl of records would be required for retrieval of any relevant information, it is not possible to offer any refinement for Request 1.

In relation to Request 2, PSNI can advise;

Enquiries made in relation to this request failed to locate any records or documents relevant to your request based on the information you have provided.

No records are kept of deployment of D13. Accordingly, we have determined that the Police Service of Northern Ireland does not hold the information to which you seek access.
