Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request

Based on what it contains, I will revise my request to only include the monthly number of cases involving the non-consensual sharing of intimate images from Jan 2016 till the most current date available,.

Request 1

The monthly number of cases split by outcome, and

Request 2

The monthly number of cases split by the age of the victim.

Note

Police recorded crime figures are compiled according to Home Office guidance set out in the Home Office Counting Rules for Recorded Crime. Under this guidance, circumstances relating to 'revenge porn' where the victim is aged under 18 will most likely to be recorded as an obscene publication offence.

Figures are provided from 2016 as these offences were enacted in Northern Ireland under the Justice Act (Northern Ireland) 2016 and no offences were recorded prior to April 2016. Please note that figures from 1st April 2022 are provisional and subject to change.

Outcome figures are subject to revisions, as investigations are completed and as outcomes continue to be assigned. I have provided all outcomes since assigned to the crimes as at 21 October 2022.
