#### **Request and Answer:**

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold some information to which your request relates and this is being provided to you. We do not however hold the information in relation to request number 2 below. We have also provided you with links to guidance issued by the Information Commissioner's Office which we have followed in responding to your request.

### **Request 1**

The FOI request in relation to officers that have vacated or resigned their posts within the last three years:

### Request 1A

Those with less than two years within completion of their probationary period;

### Answer

102 Police Officers.

### **Request 1B**

Those that have served less than a three year period and,

# **Clarification Sought**

In addition, the total breakdown of the costs incurred for the officers that will includes training

expenditure and UUJ Diploma expenditure in each of three questions, as above, can you please clarify what exactly you are asking within this part of the question.

## **Clarification Received**

I refer to your email below and I assumed at the outset on the 19th October 2022 that it was clear and evident what information I require in the first instance, however, I will break this down in simple format as follows:

1) The costs with an attached total breakdown incurred during the continuance of the training for each student officer, such as - uniform, accommodation, catering, teaching and assessment including trainers costs;

2) The total breakdown of charges made to the PSNI by UUJ in the delivery and associated costs incurred for the successful completion of the Policing Diploma for each candidate. This should include lecturer fees, marking and assessment fees and teaching costs.

### Answer

Enquires made in relation to your request failed to locate the exact costs that you have requested, however PSNI can advise you that the average cost to train one student officer is  $\underline{22,365}$ . Please see below for a breakdown of the costs incurred.

The cost for teaching etc. which we use currently is  $\underline{\pounds16,953}$  per student. This is an estimate for the cost for all College staff involved in training Student Officers and other costs such as Role Player costs, UUJ fees, vetting & range hire. This is based on 22/23 ready reckoner costs & a cohort of 340 students a year.

Please see figures below for current UUJ charging for Level 5 Student Officer training – please note that this course is delivered by PSNI staff. UUJ have confirmed that they are content for these figures to be released.

- Limb restraints
- Body armour and pouches
- Boots
- Leather warrant car holder for attestation
- Shoulder number epaulettes
- Handcuffs
- Handcuff pouch
- Baton

The only catering costs that PSNI hold in relation to the students are tea/coffee etc for their attestation. PSNI can advise that for recent squads this cost has been between  $\underline{\pounds450}$  and  $\underline{\pounds498}$  for the events.

PSNI can also advise that when Student Officers go to train at Ballykinler they get an allowance of  $\pounds$ 6.62 (+ VAT PP) for lunch.

PSNI do not hold information in relation to electricity or other utility costs in relation to student officers, however, we can provide the total costs for the police college in the 2021/22 financial year for utilities and rates. The costs provided are for the whole site for an entire year and not specific to student officers. Please see below 2021/22 costs for rates and utilities.
