### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

## Clarification sought

Can you clarify if you want an overall figure for each rank/year?
Can you also advise as to a year i.e. Financial, calendar or September to August?
Also Gross or net?

It should be noted Officers would be on different hourly rates of Basic Pay.

#### Clarification received

Please can you provide overtime statistics for PSNI Constables and Sergeants for each of the following years:

- September 2017 to August 2018
- September 2018 to August 2019
- September 2019 to August 2020
- September 2020 to August 2021
- September 2021 to August 2022

Responses to previous FOI requests quoted overtime as an overall percentage for Constables and for Sergeants. The rates previously quoted for September 2016 to August 2017 were 23% and 21%. Overtime based on gross pay would be more useful.

## Request 1

Please can you provide overtime statistics for PSNI Constables and Sergeants in each year from September 2017 to date, expressed as a percentage of basic pay?

These are the figures for overtime based on BASIC Pay bill for each rank

Sept to Aug	Constable	Sergeant
17/18	19%	21%
18/19	17%	19%
19/20	15%	17%
20/21	15%	17%
21/22	15%	16%

Please note these figures are yearly for the period September to August in line with Pay Awards.
