#### Answer

PSNI have virtual courtroom facilities in all Custody suites with the exception of Dungannon (due to wifi connectivity) however, this is presently being addressed. All of them are remote and conducted in interview rooms (see above re numbers). Additionally, Musgrave suite has a further room dedicated for remote courts.
