With respect of police officers only, the total legal costs associated with discipline, specifically the hiring of both senior and junior barristers in respects of both panel and PSD for the purpose of disciplinary hearings within the PSNI in each of the following calendar years – 2018, 2019, 2020, 2021 and 2022 (YTD).

Please see the table below outlining the total legal cost associated with discipline, specifically the hiring of both senior and junior barristers in respect to both panel and PSD for the purpose of disciplinary hearings within the PSNI in each of the following calendar years 2018,2019,2020,2021 and 2022 in respect of police officers only.
