Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

I am seeking your assistance in sourcing recruitment statistics in relation to the Police Service Northern Ireland.

Request

Specifically, I would like to obtain data on the number of applicants who applied for Police Constable vacancies, the number of vacancies available and the number of applicants who were successfully recruited (separately) for each of the years: 2013 to 2022.

Answer

Please see the table below which details the number of Student Officer applicants and appointees each year from 2013 to 2022. Please note that appointments are made in line with the available budget and taking into account the number of leavers each year. There were no Student Officer recruitment campaigns in 2016, 2019 and 2022, and no appointments took place in 2013.
