#### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold some information to which your request relates and this is being provided to you. The decision has been taken to disclose the following.

### Request 1

The top 10 excess speeds detected on the roads in the North Down Parliamentary constituency in the last 3 years.

### Request 2

Can the response include the location of each offence, the speed recorded, the date and the penalty (if any) issued.

### Answer to Request 1 and 2

Unfortunately we cannot provide the data you have requested pertaining to the North Down Parliamentary Constituency. The lowest geographical district that is available is by Policing District. Therefore we could only provide the top 10 speeds detected for Ards & North Down District for  $1^{st}$  December  $2019 - 30^{th}$  November 2022.
