### Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

#### Request 1

How many potential wildlife crime reports have the PSNI received from 2019-2022, could this please be broken down by year?

#### Answer

2019 – 6492  
2020 – 5137  
2021 – 5534  
2022 - 5443

These figures have been obtained from Police Databases and were extracted on 6 March 2023. Each year from 2019 - 2022 was searched for individually using the following criteria :

- CCS Closing Code 1 exp – Animals, Hist – Animals, Pets / domesticated animals and Wildlife.
- CCS Closing Code 2 exp – Animals, Hist – Animals, Pets / domesticated animals and Wildlife.
- CCS Closing Code 3 exp – Animals, Hist – Animals, Pets / domesticated animals and Wildlife.

#### Note

The accuracy of these figures is subject to change and is entirely dependent upon the correct codes being applied at the time of the incident being recorded and closed. These figures are not validated by Statistics Branch and are subject to change.

#### Request 2

How many of these reports were related to wildlife crimes against badgers?

#### Answer

Please find under details of all reported badger related incidents, broken down by year, reported date, County location and nature of the report where recorded by PSNI.

The legislation relevant to this type of crime is:

- The Wildlife Order (Northern Ireland) 1985 as amended by the Wildlife and Natural Environment Act 2011.

PSNI can advise that Badgers and their Setts are protected as per the Wildlife (NI) Order 1985. Section 10(4) which states the following:

*(4) Subject to the provisions of this Part, if any person intentionally or recklessly —  
(a) damages or destroys, or obstructs access to, any structure or place which any wild animal included in Schedule 5 uses for shelter or protection;  
(b) damages or destroys anything which conceals or protects any such structure; or  
(c) disturbs any such animal while it is occupying a structure or place which it uses for shelter or protection,  
he shall be guilty of an offence*
