Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

We respectfully ride under the Freedom of Information Act for the police to confirm the average times spent in the custody suite prior to charge, for persons ultimately charged with driving with excess alcohol over the last three years.

Answer

The average time spent in custody suite prior to charge, for persons ultimately charged with driving with excess alcohol between 01 Feb 2020 and 01 Feb 2023 is **9.64 hours**.
