



## FREEDOM OF INFORMATION REQUEST



**Request Number:** F-2023-00194

**Keyword:** Organisational Information Police/Staff Misconduct and Complaints

**Subject:** Unauthorised Photos of Dead Bodies

### Request and Answer:

Your request for information below has now been considered. In respect of Section 1(1)(a) of the Freedom of Information Act 2000 (FOIA) we can confirm that the Police Service of Northern Ireland does hold the information you have requested however it is estimated that the cost of complying with your request for information would exceed the “appropriate costs limit” under Section 12(1) of the Freedom of Information Act 2000. We have explained to you below that when PSNI estimates whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if certain conditions are met. In this case those conditions are met and complying with all of your requests would in our estimation exceed that appropriate limit set out in Regulation. We have explained this further below but also we followed the Information Commissioner’s Office guidance *‘Requests where the cost of compliance exceeds the appropriate limit’* in relation to this request, which also provides further detail on the application of section 12 (1) of the FOIA. You requested the following information from PSNI:

### Clarification sought:

Do you wish for the requested information to include both internal and external complaints/investigations?

### Clarification received:

Yes, to include both internal and external complaints/investigations.

### Request 1

From 2015 to the day this request is processed, please state how many police officers have taken unauthorised photos of dead bodies.

### Request 2

Please provide a description as to what happened, and please state the year that the unauthorised photo/photos were taken.

### Request 3

Please state whether the police officer shared the unauthorised photos of dead bodies with other police officers/members of staff.

#### **Request 4**

Please state whether the police officer received disciplinary action. Please describe the disciplinary action.

#### **Request 5**

Please state the (i) the gender (ii) the ethnicity of the dead body in the unauthorised photo/photos.

#### **Answer**

Section 17(5) of the Freedom of Information Act 2000 requires the Police Service of Northern Ireland, when refusing to provide such information (because the cost of compliance exceeds the appropriate limit) to provide you the applicant with a notice which states that fact.

It is estimated that the cost of complying with your request for information would exceed the "appropriate costs limit" under Section 12(1) of the Freedom of Information Act 2000. Section 12 of FOIA allows a public authority to refuse to deal with a request where it estimates that it would exceed the appropriate limit to either comply with the request in its entirety or confirm or deny whether the requested information is held. The estimate must be reasonable in the circumstances of the case. The 'appropriate limit' is currently £600 for central government and £450 for all other public authorities including PSNI. The relevant Regulations which define the appropriate limit for section 12 purposes are The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244. These are known as the 'Fees Regulations' for brevity.

Regulation 4(3) of the Fees Regulations states that a public authority can take into account the costs it reasonably expects to incur in carrying out the following permitted activities in complying with the request:

- (i) determining whether the information is held;
- (ii) locating the information, or a document containing it;
- (iii) retrieving the information, or a document containing it; and
- (iv) extracting the information from a document containing it.

Under those regulations PSNI can calculate the time spent on each of these permitted activities at £25 per hour (thus if the activity(s) takes more than 18 hours PSNI will be in excess of the 'appropriate limit').

When a public authority is estimating whether the appropriate limit is likely to be exceeded, it can include the costs of complying with two or more requests if the conditions laid out in Regulation 5 of the Fees Regulations can be satisfied. Those conditions require the requests to be:

- made by one person, or by different persons who appear to the public authority to be acting in concert or in pursuance of a campaign;
- made for the same or similar information; and
- received by the public authority within any period of 60 consecutive working days.

Regulation 5(2) of the Fees Regulations requires that the requests which are to be aggregated relate "*to any extent*" to the same or similar information. This is quite a wide test but public authorities should still ensure that the requests meet this requirement.

Enquiries made in relation to your request have identified that retrieval of this information would exceed the 18 hour cost limit set under the FOI Act by the Secretary of State.

The information requested in relation to internal and external complaints/investigations is not held in a retrievable format that provides the information without manual intervention. The relevant business area has advised, since 2015 PSNI have received approximately 20,000 complaints, comprising approximately 33,000 allegations. To provide the information requested would require the manual examination of allegations across multiple allegation categories. Allowing for the easy elimination of some allegations, at an estimate of being able to check 3 allegations per minute, it would require over 180 hours to check the data for the period requested. Therefore the retrieval process would grossly exceed the 18 hour cost limit. This would be further increased for the remainder of your request.

In accordance with the Freedom of Information Act 2000, this letter should be considered as a Refusal Notice, and the request has therefore been closed.

### **Advice and Assistance**

Under Section 16 of the FOIA PSNI will always try to assist you to refine your request and provide advice where we can. PSNI have considered how your request may be refined to bring it under the appropriate limit as outlined below:

**Due to the existence of a separate database it is possible to provide data on officers who have been subject to formal discipline sanctions in relation to the photographing of dead bodies, covering the same time period.**

Submission of a refined request would be treated as a new request, and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant Part II exemptions.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review. In most circumstances the Information Commissioner will not investigate a complaint unless an internal review procedure has been carried out, however the Commissioner has the option to investigate the matter at his discretion.
