## Request 1

Can you please provide me with the number of retired or former PSNI staff/officers (at every level) who have been recruited in a consultancy capacity by the PSNI in the past 4 years specifically; 2018/19.

## Request 2

Please include stats for paid and unpaid positions with a breakdown to distinguish between the two.

### Request 3

Can you please provide the overall expenditure for each of these years in regards to paid consultancy jobs for retired or former officers/staff.

#### **Answer**

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland (PSNI) does not hold information in relation to your requests. Enquiries made in relation to your request for the number of ex members of PSNI who have been recruited in a consultancy capacity by PSNI failed to locate any records or documents relevant to your request based on the information you have provided.

PSNI's Human Resource Department have advised that PSNI do not employ anyone in a consultancy basis, but consultants may be paid for their services, but this would not be as an employee and would be recorded through finance invoices. Additionally, all employees are paid we do not have any employees who are unpaid.

Accordingly, I have determined that the Police Service of Northern Ireland does not hold the information to which you seek access.

#### **Advice and Assistance**

Under Section 16 of the FOIA, PSNI will always try to assist you to refine your request and provide advice where we can. PSNI can assist with the following:

- Request 1 PSNI can provide the number of leavers in the years requested as well as how
  many of those leavers returned to employment but it would be for all roles as we do not have a
  "consultancy" duty type.
- Request 3 PSNI can provide how much has been paid to the companies / businesses used for consultancy.

Submission of a refined request would be treated as a new request, and considered in accordance with the Freedom of Information Act 2000, including consideration of relevant Part II exemptions.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review.
