In order to assist you with this request, I am outlining my query as specifically as possible:

Request 1

How many instances of vehicles breaching noise camera limits have been detected since noise cameras were set up in your area? Please can I have this data broken down by financial year.

Request 2

How many fines have been issued for breach of noise cameras decibel limits in your area?

Request 3

Please can I have the total amount of fines that have been issued for breach of noise cameras decibel limits in your area, broken down by each financial year.

If this requires effort to separate the results or you do not have data for that exact date range, please send the raw data.

Answers

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland (PSNI) does not hold information in relation to your requests.

Enquiries made with multiple record owners in PSNI confirmed that we do not hold any information in relation to 'noise cameras' relevant to your request based on the information you have provided.
