Request and Answer:

Your request for information has now been considered. In respect of Section 1(1)(a) of the Act we can confirm that the Police Service of Northern Ireland does hold information to which your request relates. The decision has been taken to disclose the following.

Request 1

How many people applied for the process?

Answer

A total of 227 people applied for the E02 promotion process.

Request 2

How many people sat the test/exam?

Answer

A total of 203 people sat the test/exam.

Request 3

What was the lowest score that was successful to proceed to the next stage?

Answer

The lowest score that was successful to proceed to the next stage was 58.

Request 4

What was the highest score achieved?

Answer

The highest score of the process that was achieved was 96.

How many people scored between;

80%-71%

70%-61%
60%-51%
50%-41%
40%-31%
30%-21%
20%-11%
10%-0%
